Looking forward to future meetings.

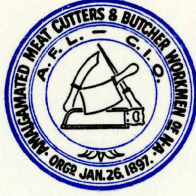

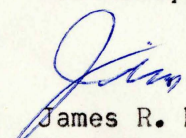
I must say, it is very nice and appreciative of the people to willingly donate their time.
