Dear Judge Rosenn:

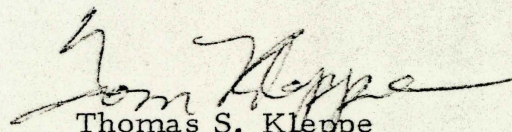
