administrators jointly and severally for and in the whole firmly by these
presents sealed with our seals dated the twentieth fifth day of May
anno 1741

The Condition of this obligation is such That if the above bounden
Ludwig pols administrator of all and singular the goods Rights & Credits of
Matthias Obold Deced^t do make or cause to be made a true and perfect Inventory
of all and singular the goods Rights and Credits which were of the said Deced^t which
have or shall come to the hands possession or knowledge of the said Ludwig pols
or into the hands or possession of any other person or persons for h^e and the same so made do
Exhibit or cause to be Exhibited into the Register General's office at Philad^a: at or before
the twentieth fifth day of June next and the same goods and Chattells which were
of the said Deced^t at the time of h^e Death or which at any time after shall come to
hands or possession of the said Ludwig pols — or into the hands or possession of any
other person or persons for h^e do well and truly administer according to Law and further
do make or cause to be made a true and just account Calculation or reckoning of the said
administration at or before the twentieth fifth day of May anno Dom 1742 and all the
Rest and residue of the said Goods Chattells Rights and Credits which shall be found Remaining
upon the said adm^{rs} acc^t the same being first Examined & allowed of by the orphans Court of
the County of Philad^a: shall deliver and pay to such person or persons respectively as the said
Court by its Decree or Sentence shall Limit & appoint and if it shall hereafter appear that any
last Will & Testam^t was made by the said Deced^t & the Exor or Exors therein named do
Exhibit the same into the said office making Request to have it allowed & approved of
accordingly if the said Ludwig pols being thereunto requested do render & deliver up
the said L^{ies} of administration approbation of such Testam^t being first had & made
in the said office then this obligation to be void or else to be & Remain in full force & Virtue
in Law
