This the same tract was sold again Dec th 8 th 1812 408 ³ / ₄ acres to Jonathan Hancock for taxes of 1802. 1804-1806-1805-1807-1809-1811-1812. for \$11.57 amount making \$32.00 Jesse Scott was sold for taxes Aug th 30 th 1805 to John Evans. & in 1816 part to George Chapman and part to Elias Hoyt.  William Sheers was sold Sept 17th 1803 to Nathan Beach 350 acres for \$9.20. Amount made \$19.20. And the same tract was sold again Dec 8th 1813 408¹/₂ acres to Gerrit van Rensselaer for taxes of 1803, 1804, 1806, 1805, 1807, 1809, 1811, 1812, 1813, 1814 amounting \$52.00

Jesse Scott was sold for taxes Sept 30th 1803 to John Evans, & in 1816 part to George Chahoon and part to Elias Hoyt.
