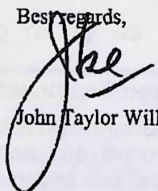
Dear Mark and Alan:

Norman and I have discussed your proposed extension of the expired Option Agreement dated April 5, 2001 as extended on April 19, 2001 and feel that the process has run its course. This letter shall serve as formal notice of termination of any oral or written understandings we have as to placement of dramatic rights for *The Naked and the Dead*.

Norman feels strongly, as do I, that if it is to be made it should be made as a feature film and, secondly, that the timing is probably (to no one's fault) not right as we are still living in the penumbra of the "greatest generation" wheel of films which want a halo over every soldier's head.
